Gates Open and Scrutineering will start from 8am.

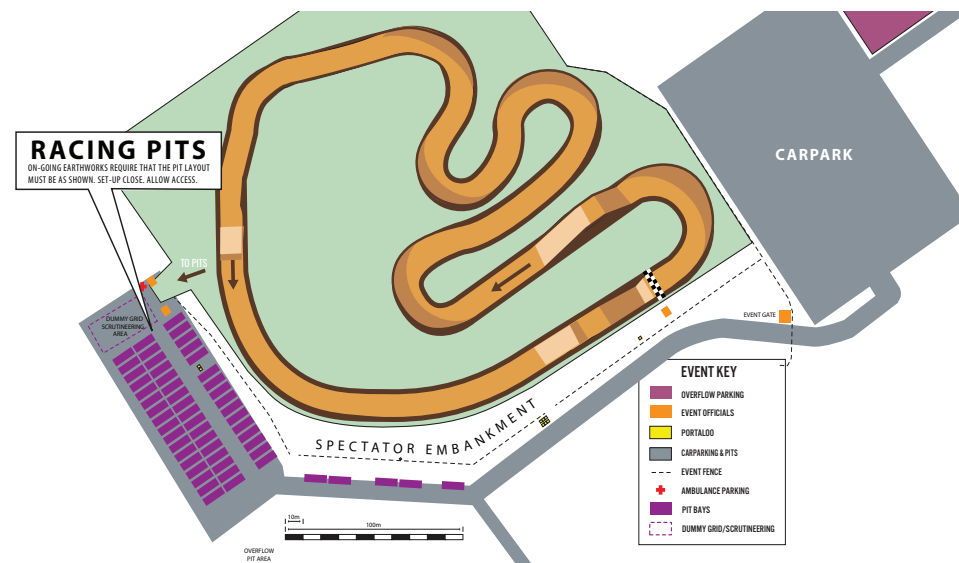
Driver's Briefing at 10:20am - **trackside photographers must attend Drivers Briefing.**

### SPECTATOR ENTRY
